## MEMORANDUM OF UNDERSTANDING

- To identify opportunities for partnership in facilitating various platforms of sharing information, best practices and systems to assist in the professional development of both CPSC member countries and NITTTR, Chandigarh network;
- To identify opportunities for professional fellowship programs and institutional development;

### Agreed Strategies

The parties will cooperate, map and implement educational and human resources development activities, which may include:


- Conduct of joint seminars, workshops, symposia, training programs, and/or conferences/special programs for sharing knowledge and technologies;
- Collaboration in facilitating study visits and exposures;
- Other innovative educational and training activities for human resources development.

**Agreed Parameters**

1. This document sets out an understanding that has been reached and as such is not intended to be legally enforceable.
2. Each party acknowledges that the other remains independent and that this understanding confers no rights unless by expressed agreement, and that each has external limits on the extent and nature of cooperation permitted between the parties.
3. The parties recognize that they are separate organizations and subject to different accountabilities and organizational guidelines.
4. This understanding will be valid for three years from the date of signing; the duration may be extended by the parties prior to that date or ended by action of the parties.



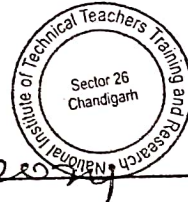


